Financial Reporting Form

- Please type or print membership or you may attach a list of your membership.
- Select and mark status for each member i.e. sapphire/life/golden life/Diamond new member or reclaim member (R/C)
- Mail **two hard copies** of the financial form with the assessment fees postmarked on or before October 31. After that date, \$10.00 late fee per Soror will be assessed.
- New Soror or reclaimed Soror are exempted from late fees.
